Subject: Approval to renew the Mico Information Products (MIP) Fund

Accounting software for the Elderly Affairs Department

Statement of Issue:

This agenda item seeks Board approval to renew the Mico Information Products Fund Accounting (MIP) software for the Elderly Affairs Department.

Background:

Abila/Community Brands is the vendor for the MIP FA by Community Brands Software program. This accounting system has been the fiscal software program used for the past 10 years and is the recommended software by Advantage Aging Solutions of North Florida (AANFS) for the grants awarded.

Analysis:

This software system renewal is effective on October 11, 2023. MIP software system has historical fiscal data stored which is used frequently for analyzing prior years' financial reporting. MIP software allows for various means of inputting, distributing, and retrieving data across many different lines of the Older American Act grant services rendered and is vital to fiscal reporting.

Fiscal Impact:

The annual renewal for the software program is \$1684.10. The renewal amount is budgeted for in the Elderly Affairs Department budget.

Options:

- 1. Approval to pay the annual maintenance fee of \$1684.10 and/or any related charges due October 2023, authorize the renewal of existing vendor terms, and authorize the Chairman to sign all related documents.
