Statement of Issue:

This item is presented to the Board for approval of Resolution Ratifying Staff Submission of a Grant Application to the Florida Department of Commerce's Rural Infrastructure Fund Seeking Funds for Design Plans to Improve and Expand the Pat Thomas Eco-Tourism Park.

Background:

The Rural Infrastructure Fund (RIF) is a reimbursement grant program within the Florida Commerce Department (Commerce), created to facilitate the planning, preparing, and financing of infrastructure projects in rural communities, which will encourage job creation, capital investment, and the strengthening and diversification of rural economies. The Florida Legislature appropriated \$25 million in federally funded State and Local Fiscal Recovery Funds (SLFRF) to the Rural Infrastructure Fund Statewide Program.

Eligible uses of funds include:

- Improvements to public infrastructure for industrial or commercial sites;
- Upgrades to or development of public tourism infrastructure;
- Improvements to inadequate infrastructure that has resulted in regulatory action.
- Project planning and preparation grants for infrastructure feasibility studies, design and engineering activities, or other infrastructure planning and preparation activities.

The maximum award is \$300,000.00 and no match requirements for applicants that are designated rural areas of economic opportunity.

Applications were due no later than November 6, 2023, and requires the local government authorizing official to sign applications or approval for staff to submit such application.

Analysis:

Gadsden County leases 13 acres of land on Lake Talquin from the Florida Department of Agriculture to operate and maintain a public park, the Pat Thomas Eco-Tourism Park. The lease permits Gadsden County to make improvements and maintain the land for a public park. Lake Talquin and the Park are important tourist destinations and economic drivers for Gadsden County.

Staff reviewed current needs and potential projects, and based on the time needed to complete an application, that the most pressing allowable project was the need for funds to hire a professional architect or engineering firm to design and provide estimated costs to develop the expanded RV sites, new amenities, and improvements to the existing developed portion of the Park. The County is also seeking 2024-25 legislative funding in the amount of \$605,377.58 for construction of the improvements and expansion of the Park. Therefore, the staff prepared the attached application sought the Chairman's signature, and submitted the application timely.

Due to the timing of Board meetings, deadlines to submit agenda items, and time needed to complete the application and to submit it timely to the Florida Commerce by the November 6th deadline, staff prepared the attached RIF application, sought the Chairman's signature and submitted the application timely to Florida Commerce. In the event the Board does not ratify these actions, staff will resend the application.

If the Board does approve these actions, then staff are seeking Board approval of a Resolution Ratifying Staff Submission of a Grant Application to the Florida Department of Commerce's Rural Infrastructure Fund Seeking Funds for Design Plans to Improve and Expand the Pat Thomas Eco-Tourism Park and the Chairman's Signature on the Grant Application

Project Description

Describe the proposed project in no more than three sentences:

Gadsden County operates and maintains the Pat-Thomas Eco-Tourism Park located at 949 Hopkins Landing Road, Quincy, Florida on approximately 13-acres leased from the Florida Department of Agriculture. Approximately six of the 13 acres are developed with 22 full-service RV sites, playground and picnic areas, fishing piers and a boat ramp, a pavilion, and other associated amenities. This project is seeking funds to contract with a professional A/E firm to design (which include identification of needed permits, environmental work, etc.) and provide estimated probable cost to develop the remaining property by constructing additional full-service RV sites and related amenities (i.e., bathhouse, pavilion, walking trail, picnic facilities, etc.) as well as needed and recommended improvements to the developed park and parking area.

Clearly summarize the proposed project as outlined in the application instructions.

The Pat-Thomas Eco-Tourism Park is considered a main tourist destination spot in Gadsden County as it provides an array of outdoor recreational opportunities and access to Lake Talquin, which is nationally known for its high-quality black crappie (speckled perch) fishery. The lake has little vegetation, but tree stumps and logs provide an excellent nursery and habitat for many of North Florida's freshwater fish species, including black crappie, largemouth bass, bluegill, redear, white bass, and white striped bass. Lake Talquin is also one of Florida's deepest freshwater lakes.

The Park is easily accessible and is no more than a 10 minute drive from the I-10 exit to Pat Thomas Highway and is at most a 30-minute drive to the various Talquin State Forest tracks located off Pat Thomas Highway and US 20, which offers close to total of 20 thousand acres for eco-tourism recreation such as hiking, mountain biking, tent/primitive camping, wildlife viewing, and fishing, kayaking and canoeing on Lake Talquin.

The County is seeking \$300,000 in RIF funding to contract with a professional A/E firm to assess (1) the developed area of the Park and provide recommend/needed improvements to the existing features with probable cost and any new improvements with probable cost; and (2) assess the undeveloped area of the Park to determine the feasibility, permitting requirements, and probably cost to develop and construct additional full-service RV sites, a bathhouse, pavilion, nature trails, picnic area and other amenities associated with Eco-Tourism parks. Once this step has been completed and reviewed with the County, the professional A/E firm will provide a design plan and specifications for improvements to the developed area and for development of the expansion to the Park. The County will require that the design and specifications are done so that all improvements, new construction and amenities are alt-adds so that bids for amenities and construction can be awarded based priority features and available funding.

Construction activities for improvements and expansion are contingent upon the professional assessment and design as well as funding.

Part III - Economic Narrative

Provide a summary of the project's economic benefit, long-term viability, and potential local or regional economic impact. The summary should include a description of the current and anticipated economic conditions of the area.

According to the US Department of Commerce, Bureau of Economic Analysis, the outdoor recreation economy accounted for 1.9% (\$454.0 billion) of current-dollar gross domestic product (GDP) for the nation in 2021. The value added as a share of GDP for Florida 3.3%. Outdoor recreation also makes up 2.1 percent of U.S. GDP, generating \$788 billion in gross output and supporting 5.2 million jobs a year. Boating/fishing, RVing, hunting/shooting/trapping, motorcycling/ATVing, and equestrian sports are the five largest conventional outdoor recreation activities in terms of economic output in the US. https://www.bea.gov/data/special-topics/outdoor-recreation. In fact, due to the impact of Outdoor Recreation activities, it was recently added as a Sector of the National Economy by the Bureau of Economic Analysis their national economy tracking, which includes outdoor recreation activities categorized into conventional activities (e.g., bicycling, boating, hiking, and hunting); other core activities (e.g., gardening, and outdoor concerts); and supporting activities (e.g., travel and tourism, local trips and government expenditures).

Gadsden County is a recognized RAO with an estimated population of 43,403, and 58.37% of this population is in the low-to-mid income range making it one of the highest LMI rates in the state, according to the most current US Census and HUD data. Gadsden also has the highest African American populations of all Florida counties, with 54.9% of the population being African American and 42.2% white, and the remaining 2.9% being Hispanic, Asian, or other. The poverty rate is 25.8%, which is 12.7% higher, or almost double, that of the State poverty rate of 13.1%. Low to mid income is one of the highest in the State with the County being 58.37%, which is over half the total population. The Socioeconomic Status of the Social Vulnerability Index, indicates an overall score of 0.9726% and a social vulnerability score 0.8415, ranking Gadsden residents at a high level of risk (i.e., stress and social vulnerability) in preparedness, response, and recovery to disasters. One hundred percent of Gadsden's public-school enrollment is eligible for free or reduced cost lunches, which is almost 30% higher than the state rate of 71% of enrollment.

It is anticipated that by improving and expanding outdoor recreational opportunities at the Pat Thomas Eco-Tourism Park that Gadsden County and the surrounding counties of Liberty, Leon and Wakulla will also follow this national trend and benefit from the infusion of tourist spending year-round. There are no retail shops or food establishment near the Park, and it is hoped and anticipated that expanding and improving the Park will spur local small boutique businesses selling and/or renting camping/hiking gear, kayak/canoes, bicycles, fishing gear, food or food truck establishments and other businesses and services associated with outdoor recreation.

Describe the proposed project's potential for enhanced job creation and/or increased capital investment, including but not limited to the following information:

According to the Department of Revenue, in FY 2022 Gadsden collected \$186,065 in local tourist development taxes, which is mainly attributed to tourist camping and fishing at Lake Talquin as well as attendance at bass fishing tournaments or seasonal hunting. By improving and expanding the Park Gadsden as an opportunity to increase its local tourism and other taxes by visitors spending in the area to enjoy the Lake and Park.

Improving and offering more and improved outdoor recreation opportunities (eco-tourism) at the Park will increase sales at local business by visitors purchasing food, fishing and camping gear, fuel, etc. as well as potentially spur small boutique businesses that could provide RV rentals, boat/kayak rental, bike rentals, food services and more. Improvements and expansion of the Park will also provide and stimulate more visitors to the nearby Talquin State Forest tracks for outdoor recreational opportunities, thereby stimulating the economy.

In summary, spending occurs on outdoor recreation in two forms: the purchase of gear and vehicles, and dollars spent on trips and travel, and both of these activities infuse dollars into the local economy to retain current business, provide opportunities for boutique retail and food businesses.

The County is in need of a professional assessment and design plans in order to pursue grant funding or dedicate County funds for construction.

It is not anticipated that the project assessment or design will have an impact on the local economy or ripple effect. However, should the County determine to move forward with improvements to the existing developed Park and construction of the expansion it is anticipated that there will be short term impact with the hiring of a general contractor and subcontractors. Local or regional firms will be hired to the extent required by law, especially of federal grant funds are used in part or in whole for construction. The County will seek public input on the Park improvements and expansion prior to commencement of any construction. However, the County has applied for RPT and FRDAP funding in the past and public input has been very favorable.

Total Project Participation Grants

To facilitate access to and maximize the use of state, federal, local, and private resources, grants may be awarded for up to 75 percent (75%) of the total infrastructure project costs, or up to one hundred percent (100%) of the total infrastructure project cost for a project located in a rural community as defined in s. 288.0656(2), F.S., which is also located in a fiscally constrained county as defined in s. 288.0656(2), F.S.
