Subject: Approval for Sheriff's Office to spend miscellaneous revenue received

directly by the Sheriff's Office

Statement of Issue:

This agenda item seeks approval for the Sheriff's office to spend miscellaneous revenue received directly by the Sheriff's office.

Background:

Florida Statute 129.06(1) requires that budgets be properly amended to adequately address additional spending. Additionally, Florida Statute 129.06(2) permits the board to amend the current fiscal year's budget. Section(2)(d) allows the budget to be amended due to receipt of a nature from a source not anticipated in the budget and received for a particular purpose, including but not limited to grants, donations, etc.

Analysis:

The Sheriff's office has directly received revenue from various miscellaneous sources and is seeking Board approval to spend the funds in accordance with Florida Statutes. The Sheriff's office received the following miscellaneous sources of revenue:

- Law Enforcement Department: Total miscellaneous revenue of \$208,002.26 received from North Florida Health Network and from Enterprise Fleet. The miscellaneous revenue is due to reimbursement of security services provided by the Sheriff's office outside of regular duties and revenue related from proceeds from terminations of Enterprise leases where the vehicle sales price exceeds the book value of vehicles returned.
- Corrections Department: Miscellaneous revenue of \$10,000 from Homewave.

Fiscal Impact:

No Fiscal impact on the Board of County Commissioner's Budget for the Fine and Forfeiture Fund.

THIS AGREEMENT is entered into and between BIG BEND COMMUNITY BASED CARE, INC., d/b/a NWF HEALTH NETWORK, hereinafter referred to as "NWFHN" and GADSDEN COUNTY SHERIFF'S OFFICE, hereinafter referred to as "VENDOR".

RECITALS

WHEREAS, NWFHN has entered into contracts with the Florida Department of Children and Families (hereinafter referred to as "DCF".

WHEREAS, NWFHN desires to retain Vendor/Vendor to provide services in connection with NWFHN's performance under the DCF Contract, a copy of the DCF Contract is available in hard copy by request, or at https://www.nwfhealth.org; and

WHEREAS, Vendor/Vendor is duly licensed, if applicable, and desires to perform the services described in this Contract in connection with NWFHN's performance under the DCF Contract.

NOW THEREFORE, in consideration of the mutual undertakings and agreements hereinafter set forth:

THE PARTIES AGREE:

- NWFHN and the Vendor agree to enter into a business agreement to fund one (1) fulltime Outreach Coordinators dedicated to assisting individuals, who are involved with the criminal justice system or at risk of being involved who are not effectively connected with services and supports needed for their treatment and recovery within the community.
- 2. The primary goal of the Sheriff Outreach Program is to promote the reduction of substance use, abuse and dependence and improve the behavioral health of the citizens of the Northwest region of the state by making substance abuse and mental health prevention, treatment, recovery, and support services available through a community-based, comprehensive, trauma-informed, integrated, recovery oriented system of care.

A. THE VENDOR AGREES:

- The Vendor agrees to employee one (1) full-time Outreach Coordinator dedicated to assisting individuals, who are involved with the criminal justice system or at risk of being involved who are not effectively connected with services and supports needed for their treatment and recovery within the community.
- 2. To maintain and submit a monthly Outreach Log, (see Exhibit A) for services provided for the duration of this agreement along with monthly invoice.

B. NWFHN AGREES:

1. To pay for services at rate(s) established through a NWFHN budget approval process for an amount not to exceed \$24,391.25 for state fiscal year 2022-23, subject to the availability of funds. The Vendor will receive five (5) monthly payments in the amount of \$4.878.25 each.

- Position will not be funded for days the position is vacant. Funding will be withheld as determined by a Daily Pro Rated amount. (\$58,539.00 divided by 365 = \$160,38)
- 3. The cost of services paid under any other agreement or from any other source is not eligible for reimbursement under this Agreement.
- 4. To remit payment to Vendor for authorized services within thirty (30) calendar days of a properly completed and approved invoice that includes a copy of the Outreach Log for the period being invoiced.
