# **Statement of Issue:**

This item is presented to the Board for approval of a Resolution Ratifying Staff Submission of a Grant Application to the Florida Department of Commerce's Rural Infrastructure Fund Seeking Funds to Create an Arts and Cultural Map and Story Board and to Partner with the ARPC.

#### **Background:**

The Rural Infrastructure Fund (RIF) is a reimbursement grant program within the Florida Commerce Department (Commerce), created to facilitate the planning, preparing, and financing of infrastructure projects in rural communities, which will encourage job creation, capital investment, and the strengthening and diversification of rural economies. The Florida Legislature appropriated \$25 million in federally funded State and Local Fiscal Recovery Funds (SLFRF) to the Rural Infrastructure Fund Statewide Program.

Eligible uses of funds include:

- Improvements to public infrastructure for industrial or commercial sites;
- Upgrades to or development of public tourism infrastructure;
- Improvements to inadequate infrastructure that has resulted in regulatory action.
- Project planning and preparation grants for infrastructure feasibility studies, design and engineering activities, or other infrastructure planning and preparation activities.

The maximum award is \$300,000.00 for planning grants with no match requirements for applicants that are designated rural areas of economic opportunity.

Applications were due no later than November 6, 2023, and requires the local government authorizing official to sign applications or approval for staff to submit such application.

Arts and Cultural Economic Sector - According to the ARPC, an arts and cultural-based economy can enhance local and regional efforts to diversify the rural economies throughout the Apalachee Region, generate revenue, improve the quality of life, and attract visitors and investment to our area. Rural areas often feature various arts and culture industries and events, which, with some assistance, can become productive economic sectors and drivers. In addition to stimulating substantial employment, arts enterprises are highly entrepreneurial, readily available in many of the Region's communities, and attract visitors to the area.

With adequate data, information, planning, and funding, the arts create a highly desirable quality of life that draws business and knowledge workers to further stimulate the economy. Leveraged correctly, arts and cultural assets attract businesses, investment, and people. Mapping cultural assets along with other community assets such as employment centers, educational institutions, and transportation nodes and corridors can also provide insight into advantageous smart growth locations where arts and culture investments can be strengthened and/or concentrated and identify new economic drivers.

The ARPC would like to partner with the County to begin this regional project in Gadsden County. The Commerce RIF grant opportunity allows for such projects, especially those that strengthen and diversify the local economy. The APRC has provided the attached proposal (Attachment #1) which provides additional information on the regional project and economic indicators.

# **Analysis:**

Staff reviewed the ARPC proposal and the County's current needs and potential projects, and based on the time needed to complete an application for an allowable project feel that this project would benefit Gadsden County and its citizens by 1) creating a map of Gadsden's current arts and cultural assets that can help strengthen and diversity the local economy by nurturing an arts and culture economic sector; 2) identifying and promoting the County's current and potential arts and culture assets; and, 3) develop a storyboard to preserving Gadsden's rich history and heritage. Proposed outreach in the community will mine stories and history from citizens that could be lost to the history books if not preserved.

The \$300,000.00 RIF funds being requested for Gadsden County will allow the County to partner with the ARPC for the following activities with strong County involvement and approval of all deliverables. Below are the two major activities with tasks that will be completed by the ARPC if funds are awarded.

#### #1 Research and Data:

- 1. Compile relevant data from existing resources, e.g., FDOT road map, Competitive Florida Community Asset Map, etc.
- 2. Local Leadership Input Hold individual meetings with the leadership team of Gadsden County and each of its municipalities to provide a briefing on the project and gather information and input.

- 3. Citizens Input Hold Public Meetings in each of the County's municipalities to provide a briefing on the project to the Public and gather input from citizens.
- 4. Storyboard Include a storytelling component as a method to gather, preserve, and integrate stories of the history of Gadsden County.

# #2 Mapping

- 1. Create a map and storyboard of Gadsden's Arts and Cultural Assets utilizing compiled data and research. The map will overlay at a minimum:
  - The Florida Trails Systems
  - Historical Designations and Landmarks
  - Other relevant and important features, such as Talquin Forest Tracks, Lake Talquin, and Pat Thomas Eco-Tourism Park.

Due to the timing of Board meetings, deadlines to submit agenda items, and time needed to complete the application and to submit it timely to the Florida Commerce by the November 6<sup>th</sup> deadline, staff prepared the attached RIF application sought the Chairman's signature and submitted the application timely to Florida Commerce. In the event the Board does not ratify these actions, staff will resend the application.

If the Board does approve these actions, then staff are seeking Board approval of a Resolution (Attachment 2) Ratifying Staff Submission of a Grant Application (Attachment 3) to the Florida Department of Commerce's Rural Infrastructure Fund Seeking Funds to Create an Arts and Cultural Map and Story Board and to Partner with the ARPC, and the Chairman's Signature on the Grant Application.

Rural areas often feature various arts and culture industries, which, with some assistance, can become productive economic sectors. In addition to stimulating substantial employment, arts enterprises are highly entrepreneurial, readily available in many of the Region's communities, and attractive to tourists. With adequate planning and funding, the arts create a highly desirable quality of life that draws business and knowledge workers to further stimulate the economy.

Leveraged correctly, arts and cultural assets attract businesses, investment, and people. The Apalachee Region is largely composed of rural areas and smaller municipalities, which often have serious challenges in competing with their larger urban cousins to achieve these kinds of successes. As such, the Apalachee Regional Planning Council proposes the development of a Regional Arts and Cultural Asset Map, to further aide in abilities for strategic planning and economic development through an arts-based economy. The mapping will begin in Gadsden County, and expand throughout the Region as the project continues. Once the inventory is conducted, the data will be analyzed in spreadsheets and spatially through the use of GIS mapping. Spatially mapping cultural assets will identify areas where arts and cultural resources are concentrated and areas where they are sparse. Mapping cultural assets along with other community assets such as employment centers and transportation nodes and corridors can also provide insight into advantageous smart growth locations where arts and culture investments can be strengthened and/or concentrated.

The Regional Arts and Cultural Asset Map is a foundational step in Arts and Cultural Planning throughout the Apalachee Region. The objective is to incorporate and safeguard cultural and artistic heritage within the framework of economic development initiatives. This entails designing, planning, and executing strategies that seamlessly integrate cultural and artistic elements. The roadmap developed will be instrumental in creating a thorough Regional Arts and Culture Plan. This plan is vital for upholding the essential role of arts and culture in defining the identity of the Apalachee Region.

Overall, this tool will allow for a better understanding of the cultural and creative value of specific community resources, enabling the Region to plan and implement a vision that fully leverages its rich arts and cultural ecosystem. In addition, the resulting data will be useful for increasing tourism and business promotion, as well as leveraging funding for community planning purposes.

In 2022, nonprofit arts and culture organizations and their audiences generated \$151.7 billion in economic activity—\$73.3 billion in spending by the organizations, which leveraged an additional \$78.4 billion in event related spending by their audiences. The impact of this economic activity is far reaching, supporting 2.6 million jobs, generating \$29.1 billion in tax revenue, and providing \$101 billion in personal income to residents.



# Part I - Applicant Profile

#### **Application Category**

There are three categories of RIF grants that applicants can request funding for. Indicate which category is being applied for:

#### **Total Project Participation Grants**

To facilitate access to and maximize the use of state, federal, local, and private resources, grants may be awarded for up to 75 percent (75%) of the total infrastructure project costs, or up to one hundred percent (100%) of the total infrastructure project cost for a project located in a rural community as defined in s. 288.0656(2), F.S., which is also located in a fiscally constrained county as defined in s. 288.0656(2), F.S.

#### Eligible uses of funds include:

- Improvements to public infrastructure for industrial or commercial sites;
- Upgrades to or development of public tourism infrastructure;
- Improvements to inadequate infrastructure that has resulted in regulatory action.

Authorized infrastructure may include the following public-private partnership facilities:

- storm water systems;
- telecommunications facilities;
- roads or other remedies to transportation impediments;
- other physical requirements to facilitate economic development activities in the community.

# **Project Planning and Preparation Grants**

Grants may be awarded for up to \$300,000 for feasibility studies, design and engineering activities, or other infrastructure planning and preparation activities. Grants awarded under this category may be used in conjunction with Total Project Participation grants.

#### Preclearance Review Grants
