## **Statement of Issue:**

This agenda item seeks Board for approval of the Granicus Intranet Proposal No Q-308712.

#### **Background:**

We recently launched our new website that will make it easier for Gadsden County residents to remain informed and for us to showcase Gadsden County online. Next, we plan to extend those efforts by adding an intranet and digital forms utility. These additions will drive operational efficiencies, by streamlining our employee forms and information delivery within our county departments.

#### Analysis:

The new intranet will allow secure internal communications that will include easy access to information such as department policies and procedures, work unit schedules, training calendars/content, and other content to specific employee groups. The development and utilization of digital forms will provide a streamlined look and help to ensure a digitized workflow. Digital forms will also be a great tool for employees to make requests in a more consistent format.

#### Fiscal Impact:

There is a one-time setup fee of \$19,200 to cover the intranet design and implementation and active directory federation service integration. A new subscription fee of \$8,800 is also required for the setup of the OpenForms license and govAccess Essentials for intranet. The total first year charges will be \$28,000.

The attached proposal is for four years of service. The annual cost of each year is listed in the table below. There is a small price increase each year that covers modifications the site may need to stay up to date.

We are requesting the yearly costs outlined below be approved at this time and included in the Information Technology budget over the next 4 years.
