Statement of Issue:

This agenda item seeks Board approval of the Supplemental Agreement for South Adams Street. (Local Agency Project – LAP).

Background:

South Adams Street - The proposed project is for the Construction and CEI of a 5' concrete sidewalk along the western side of South Adams Street. The project will start at County Road 274 MLK and end near Clark Street. No additional right of way is required.

Project Length and Mile Post Limits: 0.576 miles

Analysis:

Funds are being added due to the increase in the Resident Compliance Specialist - RCS Services. A subconsultant will be hired to complete the RCS services.

The agreement is being supplemented to add \$267.00 to CEI only - the new agreement total will be \$627,115.00.

Fiscal Impact:

FDOT has allocated funding for the above-referenced project. There will be no fiscal impact to the County.
