Subject: Approval of Flock Safety Agreement

Statement of Issue:

This agenda item seeks Board approval of the Flock Safety Agreement for the Gadsden County Sheriff's Office.

Background:

Flock Safety was founded in 2017 in Atlanta, GA, and developed the first-ever public safety operating system called Flock OS. Flock OS allows Law Enforcement and the private sector to work together to eliminate crime and shape a better future for their community.

Within the Flock OS platform are evidence-capturing devices that **Detect** when something is not right (i.e. - NCIC/FCIC Hot List Alerts), **Decode** situations in Real-time using Machine Learning and Artificial Intelligence (Vehicle Fingerprint - Make. Model, Color, and Specific Attributes) and **Deliver** objective evidence and investigative leads very quickly to the people that matter like dispatch, crime analyst, detectives, and patrol deputies.

One of the devices in the Flock OS platform that Gadsden County is purchasing is the Falcon License Plate Recognition (LPR) Camera. The state-of-the-art Falcon LPR Camera goes beyond capturing license plates.

There are over 3500 Law Enforcement Agency's using Flock around the Country and 300+ in the State of Florida including 56 of the 67 FL County Sheriff's Offices. Flock safety has helped solve over 5% of all crimes in America.

Analysis:

By utilizing advanced Vehicle Fingerprint technology, it provides real-time investigative leads to Gadsden County deputies. Integrating with nationwide, regional,

and custom Hot Lists, Flock Safety Falcon LPR delivers instant alerts for stolen vehicles, wanted vehicles, or amber alerts that enter Gadsden County, enabling the Sheriff's Office to take proactive measures to address crime.

The Falcon LPR provides more than traditional LPR cameras in that they are motion-activated. They capture any image that triggers motion, not just vehicles. For example, it can capture images of pedestrians, bicycles, golf carts, or even animals and those images would become searchable evidence within the system.

The Falcon LPR camera is a Solar Powered Infrastructure Free Subscription solution that includes everything you need, from hardware procurement and installation to cellular data, ongoing maintenance, and cloud-based software. Additionally, our team of Law Enforcement experts offers comprehensive training, continuous support, and regular updates, empowering the Sheriff's Office to utilize Flock Safety to its fullest potential.

With the Flock Safety Agreement, the Gadsden County Sheriff's Office will manage 25 Falcon LPR devices countywide.

Fiscal Impact:

The Flock Program will cost \$84,000 the first year and \$77,000 each year thereafter. Amended Funds will come for the ARPA funds initially and General Revenue for the remainder of the contract.
