Human Services Department and Coordinator Position

#### **Statement of Issue:**

This agenda item seeks Board approval of the Gadsden County Implementation Plan for the State of Florida Opioid Settlement. Also, staff are requesting approval of the creation of the Health and Human Services Department and the position description for the Health and Human Services Coordinator.

#### **Background:**

NWF Health Network (NWFHN) announced that the State of Florida, Department of Children and Families, has released non-qualified county-specific monies to support individual county plans in the utilization of funding secured by Attorney Ashely Moody via the State of Florida Opioid Settlement and will serve as the administrator of the funding between the state and our county.

Gadsden County will receive funding for the next eighteen years from the State of Florida Opioid Settlement. Each year a new plan will need to be submitted and approved by NWFHN. NWFHN is the behavioral health managing entity for the eighteen counties in Northwest Florida.

Staff have had several meetings in person as well as Zoom, and many telephone calls with NWFHN to assist in creating a plan that will best fit Gadsden County. Just recently, it was brought to the staff's attention that the 23-24 FY funding must be utilized by June 30, 2024, the State of Florida's fiscal year budget-ending cycle.

Staff has submitted the plan to NWFHN for review and approval. If approved by NWFHN, an agreement will then come back to the staff and be placed on the next available agenda for Board approval.

Additionally, Gadsden County was in Receipt of Settlement Proceeds from Walmart in December of 2022.

The State Attorney General entered a settlement with the opioid manufacturers and retailers. Walmart opted to enter into a global settlement agreement with the State to avoid future litigation. During the research, it was found that this settlement is for eighteen years as well. These funds can be tied in with the other settlement and can be used to offset the cost of the Health and Human Services Department and Coordinator Position. Staff are aware that the Opioid and Walmart settlement funds will diminish annually after the second year. Consequently, we are proposing to tap into the Indigent Care funds, or any other funding determined to compensate for this anticipated decrease.

Due to the short turnaround of the usage of the 23-24 funds, staff have created a plan for April, May, and June of 2024.

The County Administrator was asked to develop and bring before the Board a position description for the Health and Human Services Coordinator. The position of the Health and Human Services Coordinator plays a pivotal role in facilitating access to healthcare services and improving health outcomes within Gadsden County. This position involves coordinating various healthcare initiatives, programs, and resources to address the unique needs of the community. The Health and Human Services Coordinator works closely with healthcare providers, community organizations, and government agencies to ensure the efficient delivery of healthcare services and promote wellness initiatives.

The Health and Human Services Coordinator will play an integral part in the Gadsden County Implementation Plan. The coordinator will make sure that the plan is implemented as well as report on all aspects of the plan.

#### **Analysis:**

Staff have included the Implementation Plan, the overview for the Office of Health and Human Services Department, and the position description for Board review and approval.

#### **Fiscal Impact:**

The funding will come from the State of Florida Opioid Settlement Funds, Indigent Tax, or any other funding source determined.

#### **Options:**

# Implementation Plan

Non-Qualified County

#### **OBJECTIVES**

Objective: Maximize the impact of the \$209,544 opioid settlement funding allocated to Gadsden County towards addressing the opioid crisis and supporting affected communities.

#### Key Strategies:

- 1. **Community Outreach and Education:** Allocate a portion of the funds to community outreach programs aimed at educating residents about the dangers of opioid misuse, addiction treatment options, and available support services.
- 2. **Treatment and Recovery Services:** Invest in expanding access to evidence-based treatment programs, counseling, and rehabilitation services. Collaborate with local healthcare providers and support organizations to ensure comprehensive care for individuals struggling with opioid addiction.
- 3. **Prevention Initiatives:** Implement prevention initiatives targeting at-risk populations, such as youth and individuals with chronic pain conditions. This may include school-based education programs, physician training on responsible opioid prescribing practices, and public awareness campaigns.
- 4. **Data Collection and Monitoring:** Establish mechanisms for data collection and monitoring to track the effectiveness of funded programs and interventions. Use this data to inform future decision-making and ensure accountability in the use of funds.
- 5. **Collaboration and Partnerships:** Foster collaboration among local government agencies, healthcare providers, community organizations, and other stakeholders involved in addressing the opioid crisis. Leverage existing resources and expertise to maximize the impact of the funding and avoid duplication of efforts.
- 6. **Long-Term Sustainability:** Develop a sustainability plan to ensure the continued availability of services beyond the initial funding period. Explore opportunities for grant funding, public-private partnerships, and integration of opioid-related initiatives into existing healthcare and social service systems.

Conclusion: By strategically allocating the \$209,544 opioid settlement funding towards evidence-based interventions and fostering collaboration among stakeholders, Gadsden County can make significant strides in combating the opioid crisis, supporting individuals affected by addiction, and building a healthier, more resilient community.

#### SCOPE OF WORK AND DESIRED OUTCOME:



- 1. Contracted provider to develop and implement an evidence-based opioid education and prevention program within all Gadsden County schools. The desired outcome is to reduce the likelihood of future OUD among this population in Gadsden County.
- 2. Contracted provider and/or Gadsden County to develop and launch a county-wide initiative to educate residents about opioids and their benefits and/or risks. The desired outcome is to increase residents' knowledge base about what opioids are and how to avoid developing an OUD.
- 3. Contract with provider(s) to administer court-ordered substance use disorder assessments and provide treatment recommendations to the courts. Desired Outcome: 1) Assist the criminal justice system in identifying individuals (adult and juvenile) with OUD/SUD for treatment.2) Provide individualized treatment plans and access to various treatment models as an alternative to incarceration.
- 4. Contract with the provider for OUD treatment services to provide court parties with more case disposition options. Desired Outcome: Provide access to OUD/SUD treatment for criminal justice-involved individuals to reduce recidivism.
- 5. Provide funding for ancillary services via the Gadsden County Administration and/or Health Department to assist those receiving OUD treatment services with ancillary needs such as housing, transportation, and childcare. Desired Outcome: Provide support services to help ensure the successful completion of treatment modalities to decrease the likelihood of relapse.
- 6. Contract with provider for data compilation, analysis, and development of annual reporting as required by the Opioid Abatement Council.

  Desired Outcome: The analysis will support administrative decisions of program continuation or modifications to reduce the impacts of OUD/SUD on the criminal justice system and community.
- 7. Provide .5FTE funding for a Gadsden County Health and Human Services Coordinator. This position will be responsible for developing, implementing, and managing all programs and initiatives for the Gadsden County Opioid Program. Desired Outcome: To have dedicated in-house personnel to coordinate and ensure all programs are implemented, tracked, monitored, and analyzed for its impact in the county.

## Gadsden County Office of Health and Human Services

#### **OUR MISSION:**

To serve as a safety net to enhance the quality of life for Gadsden County residents by providing resources and access to social services.

#### PROGRAM DESCRIPTION:

Through its many programs and services, the Office of Health and Human Services will promote and support the health, safety, and welfare of all Gadsden County citizens.

HSCP partners with the community through many safety net organizations and its citizen committees to address the needs of the most vulnerable populations of Gadsden County such as the Gadsden Community Health Council, made up of local health providers and partner organizations such as the FSU College of Medicine and FAMU School of Nursing, the Gadsden County Health Department and others who have helped with aggressive campaigns to promote access to health care services residents of Gadsden County.

#### STATUTORY REQUIREMENTS:

The following social service functions of the Office of Health and Human Services are requirements of State law.

Disposition of Unclaimed Bodies and Chapter 245.06 F.S. Health Care Responsibility Act - Mandated under Chapter 154 F.S.

Indigent Burial Program - Chapter 406.50 F.S. and Gadsden County Policy 83-3

Medicaid Match Program - Mandated under Chapter 409 F.S.

Mental Health Program - Mandated under Chapters 394 and 396 F.S.

Opioid Settlement Program - Mandated under the State of Florida Opioid Settlement

#### **FUNCTIONAL RESPONSIBILITIES:**

The Gadsden County Office of Health and Human Services will provide the following social services programs, either directly or indirectly:

 Health Care Responsibility Act - This program funds out-of-county emergency hospital care for indigent Gadsden County patients

- Human Service Grants Based upon the recommendations of a citizen advisory committee, the County awards grants to local human service providers through HHS.
- Indigent Burial Program This program provides for the cremation or burial of qualified indigent and unclaimed deceased persons at the County's expense and in the County's pauper cemetery.
- Medicaid Match Program As mandated by State law, the County pays 35% of the cost of hospitalization for Gadsden County Medicaid patients with hospital stays extending from the 13th through the 45th day. \$55 per month is also paid for each County nursing home resident.
- Mental Health Program As required by State law, Gadsden County provides matching funds for acute care programs such as the Baker Act, community mental health programs, alcohol abuse/chemical dependency treatment, and transporting clients to the State hospital. The County pays 25% of the program costs exclusive of third-party payments, fees, and other local contributions for its indigent residents. The State of Florida funds the remaining 75 percent.
- Opioid Program As required by the State of Florida Opioid Settlement, Gadsden County will develop, implement, and manage all the county's opioid initiatives to discourage or prevent misuse of opioid drugs.

#### **Health Care Responsibility Act (HCRA)**

In 1977, the Legislature declared that it is inequitable for hospitals and taxpayers of one county to be expected to subsidize the care of out-of-county indigent persons. To ensure that adequate and affordable health care is available to all Floridians, the Health Care Responsibility Act (HCRA) was enacted. The Act places the ultimate financial obligation for an indigent patient's out-of-county emergency care on the county in which the indigent patient resides. The Health Care Responsibility Act can be found in Chapter 154, Sections .301 - .331, Florida Statutes, and Rule Chapter 59H-1.001-.015, Florida Administrative Code.

#### **Indigent Burials**

Florida law states that all counties are charged with the burial of unclaimed or indigent bodies at the county's expense. The law was enacted to ensure that unclaimed or indigent bodies are properly disposed of for public health purposes.

In Gadsden County indigent burials are coordinated between local funeral homes and Gadsden County Public Works by the Office of Health and Human Services. Unclaimed or indigent bodies are cremated or buried at the Gadsden County Cemetery

#### Eligibility

- Eligibility is based on federal poverty guidelines.
- Insurance, income, and assets will be reviewed to determine eligibility.
- Gadsden County does not supplement funeral expenses.

From the Second year through the end of the grant, the opioid funding will decrease by nearly 52.15%. Therefore, to maintain the operational level of the program, funding from the Indigent Care budget and the Walmart Settlement must increase by 70%.

From the Third year through the end of the grant, the opioid funding will increase by nearly 8.31% from the prior year. Therefore, to maintain the operational level of the program, funding from the Indigent Care budget must increase 11% and the Walmart Settlement will decrease by 48%.
