Amendment Request to Authorize Expenditure of Courthouse Facilities Reserve for Related Emergency Repairs to the Public Address System in the County Felony Courtroom located at the Guy A. Race Courthouse

Annex and Other Expenses

Statement of Issue:

Throughout this year we have had numerous failures of the public address (P.A.) sound system located in the Guy A. Race Judicial Complex Felony Courtroom. These failures have ranged from minor annoyances to catastrophic failures. Until recently, we have been able to restart, reconfigure, repair, and replace components. However, the system has now failed completely. The 2nd Judicial Circuit Court Administration planned to request a new P.A. system during the upcoming budget cycle, however the hardware did not last as long as we anticipated.

Currently, the P.A. system is not amplifying audio and several microphones no longer work (microphones have been replaced without improvements). As a result, Court Reporters are unable to reliably record courtroom procedures and viewers in the gallery are unable to hear proceedings.

Background:

The original Guy A. Race Judicial Complex Courtroom #2 P.A. system has catastrophically failed. Board actions this fiscal year (FY 2013-2014) upgraded the courtroom sound system at the Main Courthouse (courtroom #1) to be compliant with courtroom technology and due process requirements. If approved, this necessary emergency audio replacement for Courtroom

#2 will bring all of Gadsden County courtrooms to the same audio quality. All three Gadsden courtrooms would then be similar and compliant with court reporting requirements.

The existing P.A. system was installed over 10 years ago, which is well beyond the 4-5 years life cycle of similar systems. Replacing this system is a priority and funds should be provided to replace the entire sound system. We are in the process of doing an informal bid for this task, according to the County's policy. Once the decision is made regarding the vendor, the County Administrator will process the proposal. The attached budget amendment places the funds in the accounts which will allow the County to fix the P.A. system as quickly as possible.

Additionally, the repairs to the courtroom continued into FY14; thereby causing the need to draw down \$32,000 to cover the remaining FY14 budget including the P.A. system.

Analysis:

The FY 2014 budget for Activity 712 Courthouse Facilities, Department 0521 Courthouse – Facilities, comes from revenue generated under section 318.18(13)(a)1, Florida Statutes. This revenue may *only* be used for courthouse facility-related expenditures and does not impact the general fund. Earlier in FY 2010, the Board had the foresight to raise the fee from \$15 to \$30.

Fiscal Impact:

As of the September 30, 2013 audit, the Courthouse Facilities Fund had a balance of \$347,478 with sufficient reserves to address the need. Additionally, collection amounts remain approximately \$23,000.00 monthly. As such, the actual reserve fund balance will be slightly higher and continue to grow and replenish during the replacement.

Options:

Option 1: Approve the Budget Amendment and Resolution 2014-011 and authorize the

County Administrator, Finance Director and the Sr. Management & Budget

Analyst to complete and execute the documents.

Option 2: Do not approve the Budget Amendment.
