As defined by Section 58-142 of the Gadsden County Code of Ordinances, "A 'festival' means any gathering of persons for the primary purpose of listening to or participating in outdoor musical entertainment offered to the general public or a substantial segment thereof."

Exemptions (Section 58-150):

- A. The previous sections shall not apply to a festival if:
 - 1. The promoter files an affidavit that his best estimates of probable attendance at the festival is five hundred persons or less; and
 - 2. The County Administrator concurs in the estimate.
- B. Each attendance estimate by the promoter and by the County Administrator shall be accompanied by written statement of the basis for the estimate. Each estimate shall be based upon all the relevant factors known at the time, including, without limitation, past attendance at similar functions having the same and similar performers, both in Gadsden County and comparable communities, the price of admission and the extent of advertising and promotion contemplated.
- C. No person staging, promoting, or conducting a festival under an exemption certificate pursuant to this section shall permit the festival to continue for more than five hours in any forty-eight hour period or advertise or permit any advertising that a festival will so continue.
- D. It shall be unlawful and a misdemeanor to violate this section.
