Subject: First Amendment to Agreement for Mural Painting Services

Statement of Issue:

This agenda item seeks consideration of the First Amendment to the Agreement for Mural Painting Services with Charles Johnston d/b/a C5 Artworks.

Background:

The Gadsden County Board of County Commissioners (the “Board”) previously solicited Request for Proposal No. 16-08 for mural painting services on the west side of the building located at 1 E. Jefferson Street on the southeast corner of Jefferson Street and Adams Street in Quincy, Florida. The BOCC selected Mr. Johnston for the services and entered into an Agreement for Mural Painting Services dated May 12, 2017 (the “Agreement”). Upon commencement of services, the BOCC, Mr. Johnston, and the Florida Historical Society determined that additional surface area of the wall required repainting. Mr. Johnston offered to paint the additional area for additional compensation. County staff requested quotes from other vendors for the painting of the additional area and determined that the additional compensation to Mr. Johnston is approximately equal to the cost of repainting the additional area.

Analysis:

Attached is a proposed First Amendment to Agreement for Mural Painting Services. If approved by the Board, it will amend the Agreement to increase the surface area of the building to be painted, to increase the compensation to the Contractor, and to establish the specific design of the mural.

Fiscal Impact:

The compensation under the Agreement will increase by \$4,950.00, for a total amount of \$23,500.00. However, the County would have to expend approximately the same amount to repaint the additional area. Funds in the amount of \$25,000.00 are budgeted for this service.

Options:

1. Approve the attached First Amendment to Agreement for Mural Painting Services and authorize the Chairperson to sign.
2. Propose changes to the attached First Amendment to Agreement for Mural Painting Services and authorize the Chairperson to sign with changes.

**FIRST AMENDMENT TO
AGREEMENT FOR MURAL PAINTING SERVICES**

THIS AGREEMENT is effective as of the 18th day of May, 2017 (the "Effective Date"), by and between GADSDEN COUNTY, FLORIDA, a political subdivision of the State of Florida (the "County") and CHARLES JOHNSTON d/b/a C5 ARTWORKS (the "Contractor").

WHEREAS, the County has determined that it would be in the best interests of the citizens of Gadsden County, Florida, that the County be able to utilize the services of private parties when such services cannot be reasonably provided by the County; and

WHEREAS, the County has a need for mural painting services on the building located at the corner of Jefferson Street and Adams Street in Quincy, Florida; and

WHEREAS, the County has determined that it would be in the best interests of the citizens of Gadsden County, Florida to contract for these services rather than hiring the necessary personnel to satisfy the needs of the County; and

WHEREAS, in order to secure the most qualified contractor and lowest cost for these services, the County issued a solicitation for such services; and

WHEREAS, the Contractor submitted a response to the solicitation; and

WHEREAS, the County determined that it is in the best interests of the citizens of Gadsden County, Florida to contract with the Contractor to provide such services; and

WHEREAS, the County and the Contractor entered into an Agreement for Mural Painting Services dated May 12, 2017 (the "Agreement"); and

WHEREAS, the County and the Contractor desire to amend the Agreement to increase the surface area of the building to be painted, to increase the compensation to the Contractor, and to establish the specific design of the mural.

NOW, THEREFORE, for and in consideration of the foregoing recitals and the mutual covenants, promises, and obligations set forth herein, the receipt and sufficiency of which are conclusively acknowledged, the parties agree as follows:

The Agreement is amended as follows:

Paragraph 1 is replaced in its entirety as follows:

1. SERVICES TO BE PROVIDED

The Contractor agrees to provide the following services to the County: mural painting services on the west side of the building located at 1 E. Jefferson Street on the southeast corner of Jefferson Street and Adams Street in Quincy, Florida pursuant to and in accordance with the requirements set forth in Gadsden County Request for Proposal No. 16-08 and Contractor's Proposal in response to Gadsden County Request for Proposal No. 16-08 attached hereto as Exhibits A and B, as amended by the Quote and Rendering attached hereto as Exhibits C and D. All Exhibits are incorporated herein to the extent that they are not

inconsistent with the body of the Agreement. Specifically, Contractor shall paint the entire wall on the west side of the building located at 1 E. Jefferson Street on the southeast corner of Jefferson Street and Adams Street in Quincy, comprising approximately 2,300 square feet, in accordance with the Rendering attached as Exhibit D.

Paragraph 4 is replaced in its entirety as follows:

4. CONTRACT SUM/PAYMENT SCHEDULE

The Contractor agrees that he shall receive payment for services performed in the total amount of \$23,500.00 upon satisfactory completion of the painting of the mural, as determined by the County Administrator.

The Contractor shall not be entitled to payment of any amounts if this Agreement is terminated or if he does not complete the painting of the mural to the satisfaction of the County Administrator.

The Agreement is hereby ratified and affirmed in all other respects and remains in full force and effect.

MURAL ART INITIATIVE

The Gadsden County Board of County Commissioners is currently accepting proposals from artists interested in creating one public art mural in Downtown Quincy, FL. This project is a public art initiative aimed at enriching the Downtown Quincy experience for visitors and stakeholders in Downtown.

A Committee designated by the County Administrator will review the proposals and make a recommendation to the County Administrator. The staff will ultimately seek board approval of the artist and mural.

PROJECT GOALS

The goals of the Mural project are to:

1. Beautify public areas in downtown which attract heavy pedestrian and vehicular traffic.
2. Visually promote the benefit of the arts throughout Gadsden County.
3. Use art as a landmark to visually connect visitors to public spaces and parking areas.
4. To educate visitors and citizens alike of the rich history of Gadsden County.

ABOUT THE PROJECT

- The project budget includes the artist(s) labor fee, surface preparation, mural protection/maintenance plan, supplies, travel-related expenses and other associated costs.
- Surface preparation may include power washing the surface, removing chipped paint, priming the wall, etc. The surface is a brick wall. (See attachment A)
- The artist will be required to apply a protective coating once the mural is completed. The medium used must be durable and able to withstand minor wear and tear and harsh outdoor elements for at least five years.
- The theme being considered: African American History in Gadsden County. (3 historical figures.) (See attachment B)
- The location for the subject mural is corner of Jefferson and Adams Street in Quincy, FL.
- The location has more than 1,170 square feet (65 feet long and 18 feet tall) of wall available for the History of African Americans in Gadsden mural.
- The mural will serve as a visual landmark and should be distinctive through use of design color, etc. Only original art will be considered.
- The design will be suitable and acceptable for public viewing of all ages.



- Artists must submit three (3) compositional mural drawings with its proposal. A final drawing will be selected from the submissions.

PROPOSALS

Artists interested in creating a work of public art should submit the following materials to be considered:

1. A narrative of the concept for the mural, including supplemental information such as medium, and approximate dimensions of the proposed mural. The narrative should convey the artistic content, colors, style of work etc. (Picture for mural will be provided.)
2. 11 x 17 drawing illustration of the proposed mural.
3. Itemized budget.
4. Estimated project completion date.
5. Wall preparation plan.
6. Mural Protection/Maintenance plan.
7. Resume, contact information and artist statement.
8. Support materials such as examples of other works and/or reviews of similar work. Examples should describe size, materials, cost and location of other public works.
9. Five bound copies of the proposed narrative must be printed one-sided on 8 ½ x 11 paper with no sheet protectors, etc. No faxed or emailed copies will be accepted.
10. Must be an experienced outdoor mural artist only.
11. Experience with portraiture strongly preferred.

EVALUATION CRITERIA

The following evaluation criteria, not listed in order of significance, will be used:

- General approach and plans to meet the scope of work requirements of the RFP, as well as overall ability to successfully complete the project within the stated schedule.
- Qualifications and experience of personnel.
- Photo examples of previous murals painted by artists.
- The artist's past performance on projects of similar size and scope.
- Total project cost.



Mural Concept for Quincy Florida: African American History in Gadsen County

The mural concept I am presenting is an homage, a portrayal of three key figures in the history of Gadsen County. Each of these people have left an indelible mark on their community for their efforts as doctors, healers and educators. As Keepers of the Hippocratic Oath, they have provided care and quality of life for all those in need, regardless of their status or resources.

My proposal encompasses the full area of the wall. The mural will be painted with Novacolor brand pure acrylic artists mural paint, on top of a correctly prepared surface and a base coat of Sherwin Williams acrylic exterior paint.

In one design, the focus is exclusively on their portraits as doctors. The background is a blend of healing colours and they are enshrined in a keyline aure of yellow. Their portraits in this design will be a naturalized version of photorealism with a full tonal range of colours used to define their character. Their names will be rendered in traditional sign lettering techniques.

In another design, key lines from the Hippocratic Oath are lettered on each figure as a reflection of their lifes' work and philosophy. Dr. William S. Stevens created a house for African Americans to find medical care, Dr. Jessie Furlow kept her vision as a caregiver for all in her town pure and true, and Dr. LaSalle D. Lefall rose to become a great educator and leader as a learned man who became the first African American president of the American College of Surgeons. Each in their own way truly embodied these phrases drawn from the Hippocratic Oath.

In my third design, their portraits oversee anecdotal events from their lives: Dr. Stevens looks down upon the house he made into a medical centre, Dr. Furlow gazes at a scene of her poor patients paying for care with chickens, produce and chores, and Dr. Lefall reminisces about his boyhood with a bird with a broken wing he healed; setting him on his path as a doctor and a leader. This design will be painted in a retro colour scheme to enhance the feeling of nostalgia; soft pastel tones and sepia tones and warm greys.

Budget for Gadsen County Public Art Mural Project

My budget for the proposed mural is based on an all inclusive rate per square foot for detailed mural work. This rate covers all aspects of the mural creation process.

The wall will be pressure washed- with minor patching repairs where needed, primed with a bonding primer and colour base coated with Sherwin Williams grade exterior paint. The mural details and top coat will be painted with layers of premium grade NovaColor mural acrylics, manufactured in California specifically for mural work. All painting will be roller and brush application.

A coat of acrylic polyurethane varnish will be applied to the mural upon completion. My work comes with a standard 3 year warranty, with the expectation that the mural will last 25 years or more.

The project will be completed app. 1 month after commencement, when site work begins.

All materials, tools and equipment required for the project are included in these rates.

I have an account with United Rentals, and may use a scissor lift if the site permits.

The Novacolor paints are colorfast and uv resistant. The varnish will contain a uv inhibitor to further prevent fading. After varnishing, the mural may be washed with a gentle soap and water solution for general cleaning. If graffiti occurs, solvent based cleaners may be used to remove aerosol.

I have assumed a variety of roles in my pursuits as a public artist, and the two I have most commonly taken on are those of artist and contractor. In both cases, I am responsible for the delivery of the desired goals of the given project and the navigation of all components and stages between conception and completion.

My methodology is the technical, realist utilization of art materials to support the conceptual narrative approach. A finished look that engages the audience successfully is of the utmost importance. As a painter, I am familiar with all types of paint and their appropriate applications. I am a hybrid, having simultaneously emerged from the worlds of fine art, sign painting and comic book/ illustration. I bounce between original art and photoshop in the design process. I am also knowledgeable with most types of surfaces and wall structures. I am a hand painter by practice, typically avoiding spray. However, I am also practiced in a variety of spray applications as well, and use these techniques when necessary. I have been finishing my work with Novacolor brand acrylic paint for some time now and warranty my work for 3 years with the expectation that the murals I create will last for at least 20 years. My specialties include but are not limited to; Client consultation, project management, project design, community consultation and engagement, painting- public spaces & monumental work, site sculpture, sculpture design for multi-casting in concrete or other media, installation & site work.

In short, I think of public art making as an organic process- an interface between the artist and the community. The end result emerges from that free exchange of ideas. I would look forward to entering into such a creative exchange with you.

Artistic Practice - C5 MANIFESTO

C5 is my professional pseudonym, my street name, my alter ego; my corporate ID. It is my conceptual signature. **C5** is the expression of my desire to achieve totality: personal evolution, service to the whole- to function as a reflection of the Creator, engaging a dialogue between the individual and the collective experience. In practice, I act out my manifesto through public art projects that function as microcosms, C5 concepts- incorporating global perspective into my artistic sensibility. My media orientation is multi-style painting, sculpture, casting and mixed media. Alliteration, metaphor, irony and a form of Conceptual Narrative are key focus in my work, with a solid foundation of realist motifs. My ultimate goal is to create iconic, poetic experiences in art for the growth of individual and collective consciousness.

With respect to my business practice as a public artist/ muralist/ sculptor, I carry \$2,000,000 in liability insurance, C5 Artworks is a registered Canadian company. I have logged in thousands of hours on various types of scaffolding, including telescopic boom trucks, scissor lifts, cherry pickers, man lifts etc. I have years of work experience on sign structures and rooftops. I carry a standard three year warranty for all work done with the expectation that the artwork created will last for many years. In many of the practices that apply to my sculpture work, where concrete, bronze, synthetic polymers and other media are used to achieve the transition from concept to on site realization, safety and durability are always taken into consideration.

Biography

Charles Johnston, aka 'C5' is a painter, sculptor, and muralist who has been creating public art for 25 years, conceiving and executing large scale murals and sculptures in concrete, mixed media and bronze. He explores motifs that are both site-specific and concept focused, with a technical, realist utilization of art materials to support his specific approach to making art. He creates poetic experiences for the growth of individual and collective consciousness, remixing archetypes and genres to create new perspectives on the human experience.

Before he became C5, Charles started his journey as an artist in Manitoba's Interlake region as a young illustrator/ sculptor in the realm of comic/ fantasy art and portraiture. He studied Fine Art in Winnipeg, evolving his representational style and expanding his horizons. The scope of his work expanded even further after a decade as a billboard painter. With an ever-expanding sense of scale and technique, a new identity began to form for Charles.

It was in this time that he became 'C5' and integrated a diverse range of stylistic motifs, materials and concepts into a new form and began to express it through a series of monumental murals and sculptures that began in Winnipeg, and have since spread out across Canada and into the U.S.A. From the 10 story wolf mural and sculptures in the northern community of Thompson to the 100 foot tall Peanut Farmer silo mural in south Georgia, Charles has become a creator of icons.

During this critical development, Charles never stopped working on his personal themes of irony and self-realization, while collaborating with communities to co-create larger visions. Conceptual multi-tasking has enabled C5 to fuel each creative act with a sense of freshness and vitality, and the artistic cross-pollination has yielded something more.

Although C5's self-incorporation has never involved graffiti, Charles has found himself aligned on a parallel track with the current street art movement. His experiences with mural art, sign writing, sculpture casting, comic art, digital and traditional art have fused together in a similar 'hybrid' fashion in his evolving role as a Canadian artist.



Quote for Gadsden County Public Art Mural Project- added surface area

My estimate for extending the mural work to encompass the remaining surface area is based on a reduced rate per square foot for extended mural work. This rate covers all aspects of the wall painting process. Extended work will be executed in conjunction with the existing mural contract.

The remaining wall area will be pressure washed, primed with a bonding primer and colour base coated with Sherwin Williams/ Benjamin Moore grade exterior paint. The mural details and top coat will be painted with layers of premium grade NovaColor mural acrylics, manufactured in California specifically for mural work. All painting will be roller and brush application.

My work comes with a standard 3 year warranty, with the expectation that the mural will last 25 years or more.




